HAZARD IDENTIFICATION

WARNING

Keep out of reach of children

Read label and SDS thoroughly before use.

Transport: Not classified as a Dangerous Good under NZS 5433:2007 Transport of Dangerous Goods on Land.

Hazard Statements: Harmful if swallowed, inhaled or in contact with skin. Causes skin irritation and serious eye irritation.

FIRST AID MEASURES

Inhalation: Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye Contact: If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes.

Ingestion: Rinse mouth with water. If swallowed, give a glass of water to drink. If vomiting occurs give further water. Seek immediate medical assistance.

Medical attention and special treatment: Treat symptomatically.

SYMPTOMS AND EFFECTS, ACUTE AND DELAYED, FROM EXPOSURE

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Ingestion: Swallowing can result in nausea, vomiting, diarrhoea, and gastrointestinal irritation.

Eye contact: An eye irritant.

Skin contact: Contact with skin will result in irritation.

Inhalation: Breathing in mists or aerosols may produce respiratory irritation.

Long Term Effects: No information available for the product.

FIRE FIGHTING MEASURES

Hazards from combustion products: Non-combustible material.

Precautions for fire fighters and special protective equipment: Decomposes on heating emitting toxic fumes, including those of hydrogen chloride. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

Suitable Extinguishing Media: Not combustible, however, if material is involved in a fire use: Extinguishing media appropriate to surrounding fire conditions.

ACCIDENTAL RELEASE MEASURES

Emergency procedures: Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

Methods and materials for containment and clean up: Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

HANDLING & STORAGE

Precautions for safe handling: Avoid skin and eye contact and breathing in vapour, mists and aerosols.

Conditions for safe storage: Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

EXPOSURE CONTROLS & PERSONAL PROTECTION
